ABOUT THE SEMINAR

The Protection of Plant Variety and Farmers' Right Act, 2001 (PPVFR Act) is an Act of the Parliament of India enacted to provide for the establishment of an effective system for protection of plant varieties, the rights of farmers and plant breeders, and to encourage the development and cultivation of new varieties of plants. This Act received the assent of the President of India on the October 30, 2001.

Plant variety protection provides legal protection of a plant variety to a breeder in the form of Plant Breeders' Rights. Plant Breeders' Rights (PBRs) are intellectual property rights that provide exclusive rights to a breeder of the registered variety.

PPVFR Act, 2001, a sui generis system, is an attempt by the Indian Government to recognize and protect the rights of both commercial plant breeders and farmers in respect of their contribution made in conserving, improving and making available plant genetic resources for development of new plant varieties and to encourage the development of new plants varieties.

The seminar aims to disseminate information ane increase awareness regarding protection of plant varieties under the PP VFR Act 2001 so as to accelerate agricultural development and stimulate investment for research and development for generation of new, high quality plant varieties. This will, in turn, provide better growth prospects for budding researchers, farmers and entrepreneurs in the agriculture sector and promote overall national growth.
