AFFIDAVIT AND UNDERTAKING BY THE PARENT/GUARDIAN

I ______ father/mother/guardian of ______ undertake and do hereby declare on solemn oath that :

- A) My ward will abide by all the rules and regulations of the University in force or as revised from time to time.
- B) I understand that the fees once deposited shall not be refunded in any circumstances.
- C) I shall personally ensure that my ward attends the classes regularly, takes the Continuous Assessment Tests, Home Assignments etc. and Trimester End Examinations in right earnest, puts in regular attendance in all papers / practicals / projects etc. participates in the curricular and extracurricular activities and does not, in any way, violate the norms of University discipline.
- D) The University fee and other dues, as in force or revised, will be paid regularly and on time.
- E) I shall personally ensure that my ward maintains perfect discipline and abides by the orders issued by the University authorities. I shall be personally responsible for his/her conduct and discipline in the University.
- F) In the event of any change in rules & regulations or syllabi and books made by the University statutory bodies, my ward shall, except in so far as the University determines otherwise, comply with the changes that apply to the year(s) he/she has not completed at the time of the change.
- G) He/She has not been found guilty of any unfair practice in the University examination Board.
- H) My ward has not been convicted of any criminal offence nor has been released on bail in connection with a criminal case. No case of criminal offence or moral turpitude is pending against him/ her in any court of law.
- I) He/She has not resorted to any act of indiscipline during the previous years.
- J) If he/she does not satisfy eligibility rules of admission and if any information given by me/him/her is found to be false, his/her admission will stand cancelled.
- K) If he/she is not found eligible for admission by the University his/her admission will automatically stand cancelled.
- L) He/she may be refused admission or if admitted, his/her admission will stand cancelled, if any of the certificates submitted by him/her are, at any stage, found to be forged or false, and The IIS University will be free to take further disciplinary action against him/her and the fees deposited by him/her shall stand forfeited.
- M) He/she will not be allowed to sit for the Trimester End Examinations if he/she falls short of the required attendance or does not take the CA test or if his/her progress in studies is not adjudged up to the mark.

Any candidate (who has been granted provisional / final admission to any course in The IIS University) not desirous of continuing his/ her admission after deposition of
the first installment of fees alongwith post dated/advance cheques, laboratory fees, security deposit and conveyance charges etc. will be entitled for refund of post dated/
advance cheque and security deposit only subject to notice / information having been given in writing by the candidate within 15 days from the date of deposition of the
first instalment of fees. Other amount of fees is non-refundable. The decision of The IIS University in this regard shall be final and binding in all cases.

- Ragging is an offence. It is strictly banned in FMS The IIS University as per the Supreme Court directives. Strict disciplinary action shall be taken against those students who are found involved in ragging. It may lead to suspension, rustication or even expulsion from the University.
- The students are not allowed to carry and use mobile phone on campus. This must be strictly followed, failing which the mobile phone may be confiscated and the students penalized with a heavy fine.
